

Stakeholder engagement and transparency work program

Purpose

In August 2015, NOPSEMA introduced the stakeholder engagement and transparency work program to improve community confidence in the offshore petroleum regime and to improve the environmental consultation practices of oil and gas companies. Since that time, NOPSEMA has implemented a number of initiatives under the work program and continued to seek feedback from stakeholders on the effectiveness of these initiatives.

This report provides an overview of:

- completed initiatives
- stakeholder feedback mechanisms utilised during the work program
- a discussion of remaining actions under the work program, including plans to address these actions.

This report represents the close out of the stakeholder engagement and transparency work program with remaining actions to be progressed through the newly established Transparency Taskforce.

Completed initiatives

Following extensive engagement and consultation with a diverse range of stakeholders, 18 initiatives were identified as priority actions to be completed as part of the stakeholder engagement and transparency work program.

Key actions that have been completed by NOPSEMA include:

- Development and launch of the environment plan activity status and summaries web page.
- Introduction of a subscription service to inform stakeholders about the status of environment plan proposals and assessments.
- Development and launch of a dedicated community information web page that provides easy access to information about offshore petroleum approvals, consultation requirements and features frequently asked questions.
- Development and publication of new guidance as well as improvements to existing guidance that
 provide more detail about the consultation processes and NOPSEMA's decision making
 considerations.
- Development and publication of brochures and fact sheets that provide clear and succinct information about offshore petroleum approval processes.
- Participation in offshore oil and gas open days that provided the community with opportunities to meet with NOPSEMA and other government agencies to discuss the offshore petroleum regulatory regime and the offshore petroleum lifecycle.

Stakeholder feedback

Throughout the work program, NOPSEMA sought feedback from a variety of stakeholders including:

- the offshore oil and gas industry
- Commonwealth and state government agencies
- environmental non-government organisations (NGOs)
- professional fishing associations and recreational groups/users
- other marine users
- community stakeholders.

Mechanisms used to gain feedback included face to face meetings, information sessions, open days, round table discussions, collaborative forums and stakeholder surveys.

In August 2015, NOPSEMA undertook a survey to gather further insight into stakeholder attitudes on the current state, and future direction, of environmental management consultation and environment plan approval processes. The survey was distributed to more than 200 stakeholders and response rates were sufficient to provide meaningful data. The <u>results from the 2015 survey</u> highlighted a number of areas where improvements to consultation practices and transparency could be made. In response to the feedback received, NOPSEMA implemented several initiatives to improve environmental consultation practices and increase regulatory transparency.

NOPSEMA committed to re-surveying stakeholders after the work program had been in effect for 18 months. The supplementary survey was distributed in March 2017 and sought feedback on the effectiveness of improvement initiatives. Response rates for the 2017 survey were very low (<5%) and as such, NOPSEMA did not consider that data collected provided a meaningful representation of stakeholder views.

NOPSEMA will continue to seek feedback on transparency initiatives through other means including, via the Transparency Taskforce.

The Transparency Taskforce

In July 2017, NOPSEMA established a Transparency Taskforce (the taskforce) to align efforts on transparency initiatives with other jurisdictions and to assist industry in identifying solutions for common issues. The taskforce is currently identifying and defining the work streams and more information will be made available on NOPSEMA's website as work gets underway. The taskforce comprises representatives from NOPSEMA, Commonwealth and state government agencies, industry groups and other relevant stakeholders.

The taskforce will build on the lessons learned and insights gained through the stakeholder engagement and transparency work program and will seek to ensure that improvements in the transparency of NOPSEMA's regulatory processes and information relevant to offshore petroleum environmental management continue to be identified and addressed.

Remaining actions

As at July 2017, two of the eighteen actions announced under the work program remain open.

These include:

- NOPSEMA will engage with the Department of Industry, Innovation and Science to discuss the feasibility of regulatory change in 2016 to improve consultation and transparency; and
- APPEA to prepare and publish a 'how to undertake effective consultation with relevant persons' methodology (or equivalent) by 30 June 2016.



Regulatory change

In response to NOPSEMA's work program, the Department of Industry, Innovation and Science (the department) prepared a detailed issues paper considering potential amendments to transparency and stakeholder consultation requirements under the Offshore Petroleum and Greenhouse Gas Storage (Environment) Regulations 2009.

The purpose of the issues paper was to:

- identify policy, legal and operational issues that could impact the effectiveness of the consultation requirements under the Environment Regulations
- discuss those issues and identify draft options to address the issues identified
- invite comments on the issues and proposed options including on their potential impacts to stakeholders, including industry and other parties.

The issues paper was open for public consultation between 22 March and 30 April 2016 and the department held public consultation sessions in Darwin (5 April), Melbourne (6 April), Adelaide (7 April) and Perth (8 April). The sessions were attended by industry, environmental NGOs, members of the fishing industry and state and Territory government representatives.

Following the public comment period and consultation sessions, a number of submissions were received and analysed by the department.

The department reached a preliminary policy position and this was presented to stakeholders at follow up information sessions. The outcomes of the review into the transparency and consultation requirements of the Environment Regulations are currently under consideration by Government.

Following Government consideration and finalisation of a policy position, NOPSEMA will work collaboratively with the department, industry and other stakeholders to develop and implement any regulatory changes. This work will be progressed through the taskforce who will ensure a smooth implementation of the broader policy framework.

The APPEA consultation methodology

Early in the development of the NOPSEMA work program, the Australian Petroleum Production and Exploration Association (APPEA), as a representative body of the oil and gas industry, requested an opportunity to contribute to improved consultation outcomes on behalf of its members. APPEA's proposed contribution was to take the form of a standardised method for undertaking consultation and was to be provided to titleholders for their use in engaging with stakeholders. NOPSEMA agreed to APPEA making this contribution on condition that any industry led methodology was prepared collaboratively with relevant stakeholders to ensure that it met their needs. Further, that the methodology sought to improve consistency and predictability in titleholder consultation practices and that it met the requirements of the relevant regulations and NOPSEMA's consultation guidelines.

APPEA provided NOPSEMA with a draft of the proposed consultation method in June 2017. Following a review of the proposed method NOPSEMA decided that progression of this initiative would continue through the taskforce.

Close of the work program

NOPSEMA has determined that the remaining two items from the stakeholder engagement and transparency work program will be transitioned to the taskforce for completion. Given all other action items under the work program have been completed, NOPSEMA formally closed the work program on 31 July 2017.
