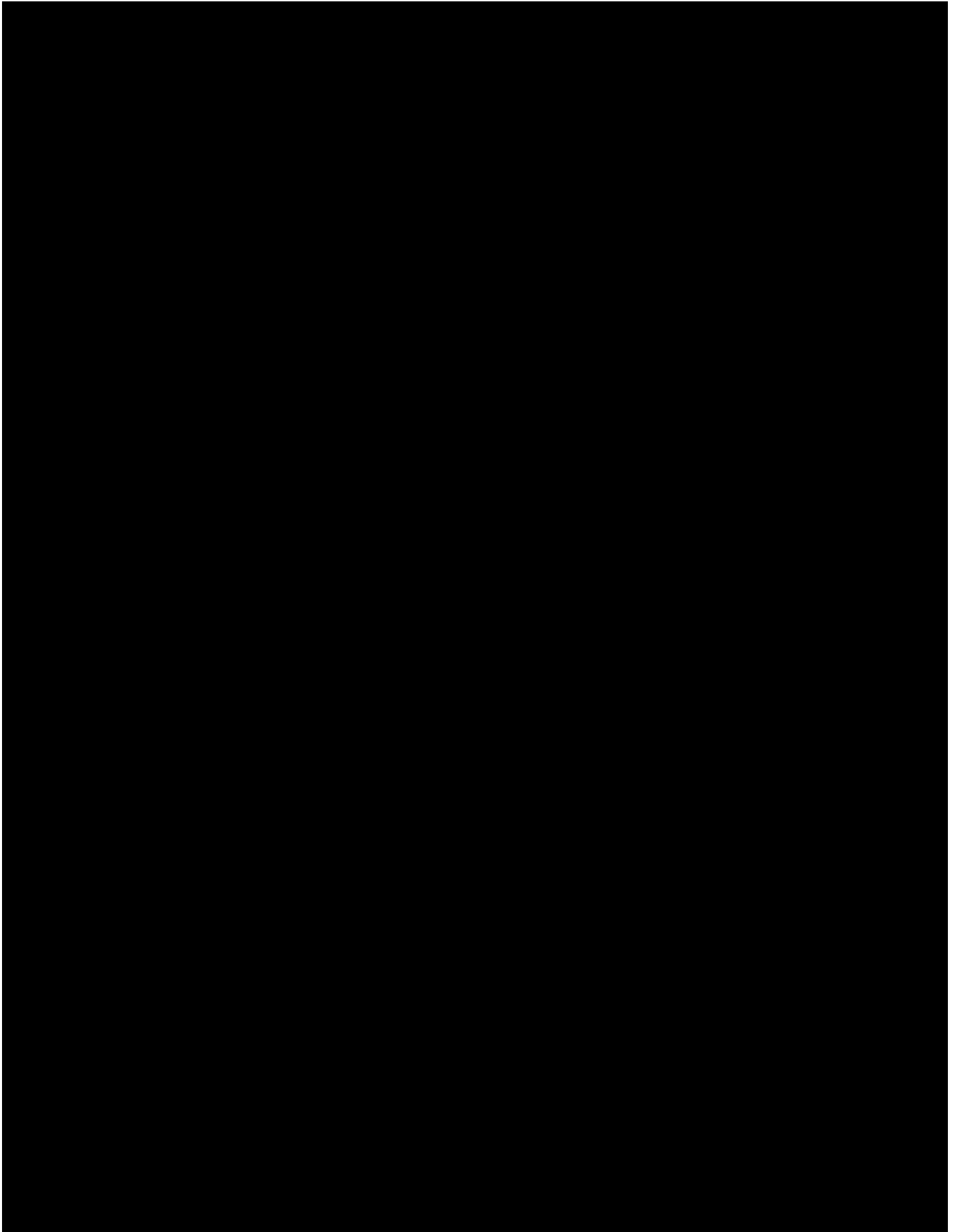



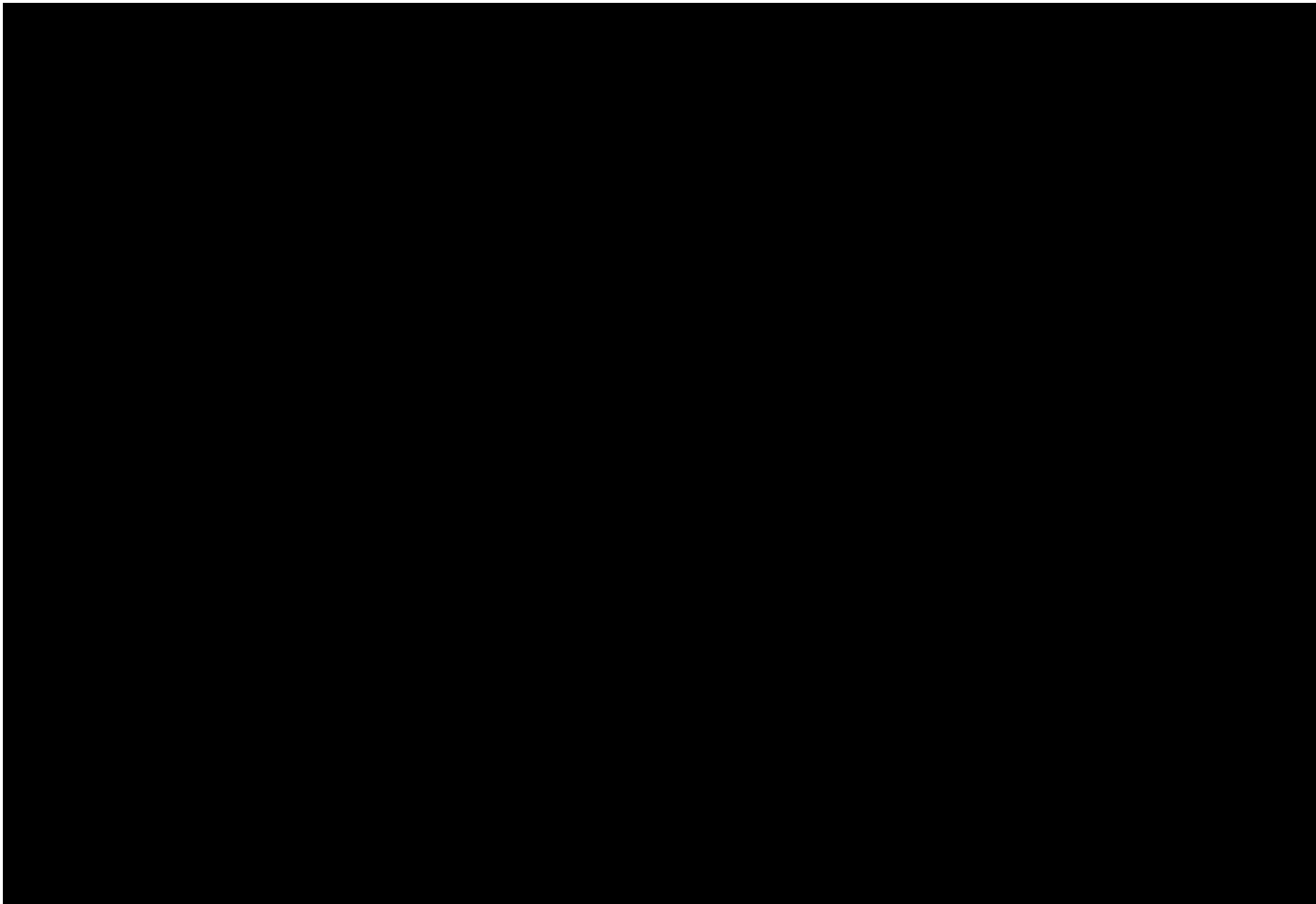

Consultation & Tipakallipa related aspects

- Santos are approaching consultation on a geographical basis, with initial 'pre-consultation' over the full lifecycle of projects, followed by activity specific consultation where stakeholders express an interest in being consulted on that activity.
 - Decommissioning and operational activities are being consulted together. Any activities with a stakeholder base that overlaps Barossa is being treated together to avoid confusion
 - Santos advised that the general direction 1898 (to identify, evaluate and manage the potential presence of underwater cultural heritage features which may have spiritual and cultural connections to sea and to marine resources) has actually had a greater impact in changing behaviour of Santos and industry more broadly than the Tipakalippa decision did.
