Thanks for prompting me on this. I understand that [REDACTED] had a discussion with NOPSEMA yesterday and I've been instructed that we'd like to request an extension to Wednesday 12<sup>th</sup> November 2025, please.

The reasons for the extension are:

- To provide sufficient time for CGG to receive the updated sound modelling report, work through the implications for control measures, and incorporate the results into the EP.
- To allow a conclusion to our 2025 SRW onshore monitoring program and for those findings to be incorporated into the EP.
- To give sufficient time for CGG to seek further advice from NOPSEMA post the conclusion of the aforementioned efforts.

We will remain in communication with you over the coming weeks, initially with meeting requests, and will keep you informed if we reach a point that an earlier submission is possible.

Separately, thank you for your recent email and advice on the cultural features queries we had. We will complete the additional checks suggested and modify the EP accordingly.

Finally, I've attached a recent paper about SRW starvation thresholds and endurance that came up through our regular checks that I thought you'd find interesting. We'll add this to the discussion in the EP along with a few other recent relevant papers that've been published since last submission.
