I am writing with respect to the Bight Petroleum Environmental Plan, on behalf of our more than 60,000 supporters.

Humane Society International (HSI) is a 'relevant person', according to the *Offshore Petroleum and Greenhouse Gas Storage (Environment) Regulations 2009* (Article 11Ad). Despite previous submissions on this issue, HSI was not consulted by Bight Petroleum on the development of their submitted Environmental Plan.

As a result, HSI has not seen the submitted Environmental Plan, nor do we have any knowledge of what it might contain.

HSI has previously raised concerns about the impacts of the proposed activities, which remained unresolved in Bight Petroleum EPBC Referral (2013/6770). As a result we have no confidence that our concerns have been addressed in this new Environmental Plan.
