In case not seen, good comments form Rowan in today's paper.

He said his party would audit the National Offshore Petroleum Safety and Environmental Management Authority (NOPSEMA), which is assessing Equinor's environmental plan for drilling in the Great Australian Bight.

"We have an independent scientific regulator and we should allow them to do their job," he said.

"(It's) just to make sure they are doing everything correctly, having said that I fully expect to find that they are doing exactly what they are meant to do... I've always had faith in them."

Mr Ramsey said voting results appeared to show that drilling in the Bight was perhaps not as big of an issue in Port Lincoln as others had claimed.
