I spoke with [REDACTED] about the slide you provided and the text CGG propose to include to address OMR letter 1.2. From what we can see, you seem to have understood the issue correctly. The proposed changes acknowledge and link the potential for an unplanned release of fuel to impact upon First Nations peoples' ability to exercise certain native title rights/interests.

The letter point raised Native title rights and fuel release as an example. Although we haven't identified any other specific gaps, we'd encourage you to check and be satisfied that other potentially relevant pathways are clearly linked and cultural features are considered in those impact/risk assessments.
