Thanks for the updates. I can see the pinching effect you refer to.

I'm getting periodically confused by the B/C terminology, so I've added in my interpretation below in blue. Please correct me if I'm wrong. I suggest we include pipe sizes (13-5/8 x 20") to avoid confusion.

In earlier emails, you mentioned *"The piping connects A & B "wellhead" annuli outlets together. So, the monitoring screen in the gas plant reads one pressure for the A&B annuli"*. Am I correct in assuming this is because there is no B annulus for this well, because of the well architecture (9-5/8" and 7" liners). Could you please confirm that the 13-5/8" x 20" annulus is monitored independently (as it appears). Also, is the 20x30" monitored?

I'm writing up our findings and will give you time to review before we meet. Will be interested in the rationale for the higher MAWOP.

 - c. include in the presentation if not already in the review above;
