06 April 2025	At approximately 1220hrs the MMA Leeuwin offshore supply vessel (OSV) was brought alongside the DPS1 for cargo operations, without the Marine Fauna Observer (MFO) 30-min observation period for pygmy blue whales (PBW's). The MFO identified from the 'Deck Logbook' that the MMA Leeuwin was alongside without the observation period (upon attending the Bridge at 1400hrs). The omission of the 30-minute PBW observation period constitutes a breach of WA-34-L Pyxis Drilling and Subsea Environment Plan.
