and I propose the following process to scope a trip to the Tiwi Islands, based on our experience and the Remote Engagement Strategy developed by the NT Government, Aboriginal Interpreter Service and IAP2 (international professional association for engagement).

Steps include:

- Meeting with NIAA regional office Wed 4 Sept to discuss TEACA and position within
 wider Tiwi community, confirm other groups that NOPSEMA may meet with (Tiwi
 Land Council, Tiwi Regional Council, Local Decision Making org); to confirm what
 assistance NIAA could provide for a visit (including logistics such as cars, office
 space, recommendation on using interpreters, accommodation options these are
 all limited on the Tiwis)
- this approach is recommended as we should be offering an opportunity for all relevant groups to meet while we are there particularly to ensure the TLC is able to extend the request to relevant parties
- Clarify the purpose of a NOPSEMA visit and risk assessment [should tie in to First Nations engagement strategy under development] – and any collateral (presentations, videos, particular SMEs etc)
- Depending on NIAA's level of assistance, reach out to Tiwi organisations TLC needs to grant a permit, to confirm best time to travel (NIAA can also provide advice) and then assist with visit promotion/details as required – including booking interpreters
- Logistics (including who from NOPSEMA will go based on planes/car space),
 NOPSEMA risk assessment/travel plan procedures, budget
- Undertake the trip
- Evaluate, note actions and close the loop/continue work identified with stakeholders

I've got a draft engagement template for this trip to accompany the above.
