Fire alarm activated sounded, fire teams and duty teams activated to stations. Announcements made to make all aware and to keep safe. Fire extinguished with powder portable extinguishers. Fire extent possibly small in comparison to previous. Now stopped work and barricading the area. Witness statements from 5 to 6 people and photos have been taken.  I have not given permission to disturb the site until NOPDSEMA Inspectors can assess. Tomorrow at 09:30 WST NOPSEMA will be interviewing witnesses from the incident that occurred 3 days ago.
