Thank you for your correspondence of 12 February 2026 regarding nomination of a Designated Public Official under section 33A of the *Offshore Petroleum and Greenhouse Gas Storage Act 2006*.

I can confirm that Transport for NSW is the appropriate NSW agency for NOPSEMA to engage with in the event of an oil pollution emergency originating in Commonwealth waters.

For the purposes of section 33A of the *Offshore Petroleum and Greenhouse Gas Storage Act 2006* (Commonwealth), as the responsible State Minister for NSW under the Joint Authority arrangements, I give notice that the Designated Public Official is the Transport Secretary, Transport for NSW. This office is currently held by Mr Josh Murray.
