- 3. Although the budget for the Employee Assistance Program has been set at \$132,000.00 over the four year period, the actual cost is dependent on employee's uptake of the program which has traditionally been lower than the budgeted amount.
- 4. The original Contract was entered into in 2018 for annual subscriptions for software licence and Cloud Hosting to allow public comments on NOPSEMA's website and was not anticipated to be over \$100,000.00. This Contract has since been extended which has increased the value to \$178,750.00.
- 5. The original Contract was entered into in 2016, but the was not for an amount over \$100,000.00. This Contract has since been extended to 2023 with services to be provided on an as required basis. It is estimated that the total value of the Contract up to 30 June 2023 will be \$231,000.00 based on invoices to date and budget allocated up to 30 June 2023.
