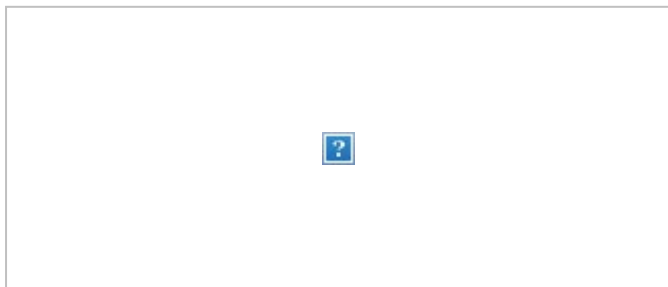

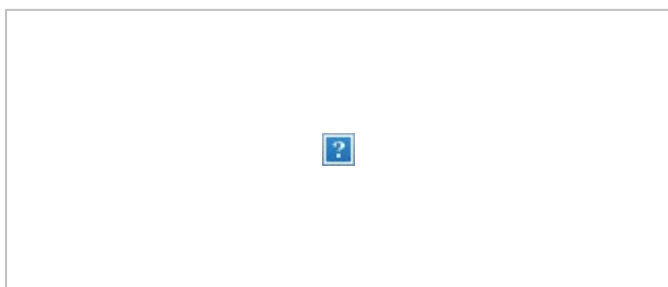

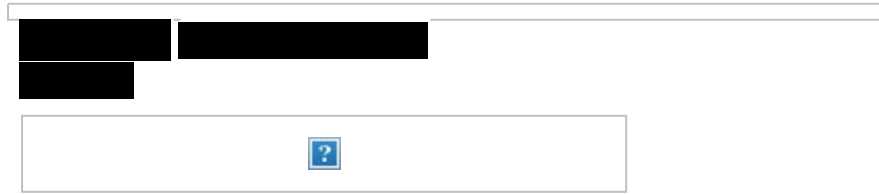
Thank you very much for your email and reaching out to arrange a meeting between TEACA and NOPSEMA.
